**Sub: De-Affiliation of Kerala Kho Kho Association – thereof.**

Dear Sir,

I am directed to inform that Kerala Kho Kho Association (hereinafter referred to as "KKKA") headed by Sh. Adv. B. Sathyan MLA as its President and Sh. G. Vidyadharan Pillai as its Secretary General, has not conducted the State Association's elections following due procedures as well as in time.

2. It is also pertinent to mention here that as per intimation to the Federation, the KKFI has appointed Sh. K. Appavoopandian, Secretary – Tamil Nadu State Kho Kho Association as observer for the procedural proceedings of the KKKA elections. But, the KKKA has re-scheduled the said elections without timely intimation to the Kho Kho Federation of India resulting non-conduct of the said elections at the prescribed date & time. The observer has taken a serious note for the same and due to non-functioning of the KKKA, it was recommended to constitute an ad-hoc committee for smooth functioning of KKKA.

3. Keeping in view, as the tenure of the existing Office Bearers with Kerala Kho Kho Association has been already completed and no elections has been convened so far, the competent authority has decided to de-affiliate the KKKA with immediate effect and consequently, an Interim Committee has been constituted to look after the operations & functionality towards promotion & development of Kho Kho in Kerala State. The members of the Interim Committee are as under:

- v) Dr. K. V. Anoop, National Kho Kho Player & Director, Physical Education – Member


