

AUDITOR'S REPORT

We have audited the Balance Sheet of KHO KHO FEDERATION OF INDIA as on 31 MARCH 2016 and the Income and Expenditure Account for the year ended on that date and report as follows:

- 1) We reiterate our observation of last year regarding payment of Award Money to the players that the same may preferably be paid by cheques at least to those players who are having bank accounts.
- 2) We have come across isolated instances where payment vouchers are not supported by original bills / receipts and we have relied upon the statement of Treasurer / Secretary in that regard.
- 3) We note with concern the arrears of various fees receivable by the Federation which are increasing every year. We urge the office bearers to pursue the recovery vigorously especially when the defaulting teams present themselves for attending subsequent tournaments.
- 4) The Closing Stock of Rule Books is as certified by the Secretary of the Federation.
- 5) The accounts include a provision for fixed allowance of Rs.2000/- per month towards telephone expenses and Rs.3000/- per month towards office expenses payable to the Secretary in terms of the resolution passed by the General Body of the Federation in 2014.
- 6) The summary of the various annual fees receivable by the Federation and the position of recovery is as under:

- 7) The federation received an advance of Rs.22,50,000/- from the Central Government towards expenditure to be incurred for Asian Games scheduled at Indore, Madhya Pradesh. We are informed that the said amount is ultimately paid to Madhya Pradesh Kho Kho Association who hosted the games in the subsequent year. Hence the said amount is carried forward in the current year
- 8) The tournament called as South Asian Federation Games was held in Gauhati, Assam during the accounting year for which total expenses of Rs.14,36,103/- were incurred. We are informed that out of these expenses bills for expenses amounting to Rs.7,06,153/- were submitted to Sports Authority of India and as such were not available for our verification. The expenditure of the tournament was incurred at various places and through a number of officials of the Federation. The Federation had paid ad-hoc advances to the officials concerned from time to time. The officials rendered their accounts of expenses incurred against these advances in a piecemeal manner after a considerable time lag so that the total expenses are spread over two accounting periods.

Subject to our remarks in the preceding paragraphs and on the basis of information and explanations furnished we report that the Balance Sheet and Income and Expenditure Account are in agreement with the books of accounts and vouchers produced before us.
