## MINUTES OF THE ANNUAL GENERAL COUNCIL MEETING OF KHO KHO FEDERATION OF INDIA (KKFI)

The Annual General Council Meeting (AGM) of the Kho Kho Federation of India (KKFI) was held on 5<sup>th</sup> July 2021 at 1000 Hrs at I-7, 7<sup>th</sup> Floor, Dhawandeep Building, 6 Jantar Mantar Road, New Delhi 110001 to hold the Elections of the Office Bearers & Members of the Executive Committee for the term 2021-2025 and to deliberate various matters pertaining to the interest and welfare of the Kho Kho Federation of India.

The Meeting Notice for holding of AGM, along with agenda points as per the date, time & location given above, was circulated among all Presidents/Secretaries, affiliated State/UT Kho Kho Associations of the KKFI on 10<sup>th</sup> June 2021.

The details of the AGM members, who attended the meeting is annexed as **Annexure I**.

### **Agenda Item No. 1: Election of Office Bearers and Executive Committee Members of the Kho Kho Federation of India for the term 2021-25.**

Hon'ble Justice Rajesh Tandon, Former Judge, Uttarakhand High Court (Nainital) was appointed as the Returning Officer (R.O.) for the conduct of the elections strictly as per the guidelines of National Sports Development Code of India (NSDCI), issued by MYAS and in conformity of KKFI Constitution.

Shri Anil Khanna, Sr. Vice President, Indian Olympic Association (IOA) attended the AGM & Elections of KKFI as IOA Observer. He expressed his full satisfaction for the fair & transparent procedure followed during the election process.

The MYAS was also requested to nominate their representative/observer for attending the AGM / Elections of KKFI vide letter No. 7-5/KKFI/GC/Elections/2021/166, dt. 16.06.2021. However, MYAS vide their letter No. 36-6/2009-SP.1/SP-III, dated 25.06.2021, conveyed that they will not be sending an observer for the elections and advised KKFI to go ahead and conduct the elections as per NSDCI.

The AGM commenced on 5<sup>th</sup> July 2021 at 10.00 Hrs. at I-7, 7<sup>th</sup> Floor, Dhawandeep Building, 6 Jantar Mantar Road, New Delhi 110001. The names of the Office Bearers and Members of the Executive Committee, who were elected unanimously were read-out by the R.O. Following Office Bearers have been elected for the term 2021-2025:

## **Agenda Item No. 4: Amendments to the Constitution, if any.**

The following amendments were proposed and circulated for consideration amongst the members of the General Council in the course of the AGM on 05.07.2021.

AFTER RULE 7.2.4(i)(g), THE FOLLOWING RULE WAS PROPOSED TO BE ADDED:

7.2.4(i)(h) It fails to hold elections regularly in accordance with its Bye-Laws, Constitution of KKFI and the National Sports Code, in a fair and transparent manner, in accordance with the Model Election Guidelines forming part of the National Sports Code.

RULE 10.1(vi) OF THE EXISTING CONSTITUTION WAS PROPOSED TO BE SUBSTITUTED BY THE FOLLOWING RULE:

No Candidate shall be qualified to contest for the post of an Office Bearer of the Federation, if he/she has attained the age of 70 years. However, a duly elected office bearer shall continue until the end of his/her term even after attaining the age of 70, provided at the time of getting elected, he/she had not yet attained the age of 70.

AFTER RULE 10.2(ix), THE FOLLOWING RULE WAS PROPOSED TO BE ADDED:

10.2(x). The federation shall endeavour to ensure that its Executive Committee, to the extent of 25%, comprises of prominent sportspersons.

RULE 12 OF THE EXISTING CONSTITUTION WAS PROPOSED TO BE SUBSTITUTED BY THE FOLLOWING RULE:

## 12. ARBITRATION COMMITTEE:

The Arbitration Committee shall be the avenue for resolution of disputes between (i) members of KKFI, (ii) members of KKFI and KKFI, (iii) officials or players, or (iv) any such matter at the national level. The Arbitration Committee will be a body comprising of a total of 05 (five) members (including a Chairperson), to be appointed by the Executive Committee, for a tenure of two years extendable by another term of two years, to conduct Arbitration in such matters. The Arbitration Committee will comprise of reputed legal authorities, eminent jurists and practitioners. The Arbitration Committee shall be impartial and ensure that both parties have unbiased opportunity to represent themselves. The members and/or their affiliated units shall have the obligation to approach the Arbitration Committee of KKFI, as the mode of resolution of any disputes.

- i) Any complaint/claim/dispute may be sent in writing by the aggrieved person/member to the Chairperson of the Arbitration Committee.
- ii) The Chairperson of the Arbitration Committee shall form an arbitral tribunal comprising of sole/three arbitrators after inter-alia, taking into consideration the complexity of the matter.
- iii) Arbitration Committee will conduct formal hearings for adjudication of disputes between parties.
- iv) The seat and venue of arbitration shall be New Delhi.
- v) The language of the arbitration proceedings shall be English.

- vi) The arbitration proceedings shall be governed by the Arbitration and Conciliation Act, 1996, as amended from time to time.
- vii) The Arbitration process will be concluded as expeditiously as possible, and shall be subject to the time limits prescribed in this regard by Arbitration and Conciliation Act, 1996, as amended from time to time.
- viii) The costs of the arbitration proceedings shall be paid by the party(ies), as directed by the Arbitral Tribunal. The costs shall include the fee of the arbitrator(s), administrative expenses, and the reasonable fee incurred in by the parties in the course of the proceedings on legal representation etc.

AFTER RULE 14.8(vi), THE FOLLOWING RULES WERE PROPOSED TO BE ADDED:

**14.8.(vii)** The State/UT members of KKFI along with their affiliated district units, shall have a legal status as a voluntary registered body, not being a proprietary concern or a partnership firm and should exist for the sole purpose of the development of the sport of Kho Kho. Further, the State/UT members of KKFI along with their affiliated district units, shall have an exhaustive written constitution in unambiguous terms, providing for its efficient functioning, in particular, election of office bearers, truly representative character of the general body, protection of the interest of players, promotion of the game, maintenance and audit of accounts etc.

**14.8(viii)** The State/UT members of KKFI must have registered district units from a minimum of 50% of the total Districts in the relevant State affiliated with them. While granting recognition/affiliation to a State/UT Association, the KKFI shall take into consideration the truly representative character of the State/UT Association so as to ensure that only the truly representative body of the sport of Kho Kho, gets recognition from each State/UT.

**14.8(ix)** The State/UT members of KKFI along with their affiliated district units, shall follow and abide by the provisions of the National Sports Development Code of India, 2011 and any subsequent amendments or subsequent instructions/directions issued by the Ministry of Youth Affairs and Sports, Government of India.

RULE 20 OF THE EXISTING CONSTITUTION WAS PROPOSED TO BE SUBSTITUTED BY THE FOLLOWING RULE:

**20.** Any amendment required to be made to any provision of this Constitution/Bye Laws, in form of alteration, extension, abridgement or amendment shall be proposed in the EC/GC meeting (whichever is held earlier) held in accordance with these bye-laws. All such proposition(s) shall be carried into effect only when the same are passed by a majority of 2/3 (two-third) of the representatives present and voting at the GC Meeting. Provided however, if any such amendment passed by the EC as per the provisions above, the same shall need to be ratified by the GC by 2/3 (two-third) majority of the representatives present and voting.

The amendments were considered and passed unanimously by the house.

The chairperson thanked all the participants for their considered views on various issues. He appreciated the efforts of all concerned for the promotion & development of Kho Kho.



Between 20.06.2021 and 22.06.2021, the undersigned scrutinised each nomination paper on a number of yardsticks provided under the Election Rules and Schedule, based on the National Sports Code, 2011 and the Constitution of KKFI, including the following:

- (i) The nomination of a candidate for election as Office Bearer should be proposed by one of the representatives of Member States/Union Territories/affiliated units whose name was included in the Electoral College list in Form 1, and also subscribed by 1 (one) such representative as seconder.
- (ii) Each candidate was entitled to be nominated by not more than 2 (two) nomination papers.
- (iii) Each Nomination Paper was to be delivered personally to the undersigned by the candidate himself/herself from (15<sup>th</sup> June 2021 to 17<sup>th</sup> June 2021 between 11:00 am to 2:00 pm.
- (iv) No person was eligible to nominate more than one candidate for the same post, either as proposer or seconder and if he does so, his/her signature on the nomination papers delivered at a later point in time would be deemed to be inoperative.
- (v) No person was to be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her had been delivered to the undersigned.

While carrying out the scrutiny of nomination papers, the undersigned also considered and decided an objection dated 15.06.2021, raised by one Mr. Santosh Parab who claimed to be life member of Maharashtra Kho Kho Association, in regard to one Mr. Chandrajit Bhalchandra Jadhav, who was alleged to be a Government Servant and not an elected member or Official Committee member of MKKA. It was further alleged that as per Ministry of Youth Affairs Circular F. No.8-33/2020-SP-II/2, Mr. Chandrajit Bhalchandra Jadhav is an illegal representative. Subsequently two documents were also submitted by Mr. Parab essentially stating that Mr. Jadhav was working as HOD Physical Education in Terna Mahavidyalaya, Osmanabad. On 21.06.2021, Mr. Jadhav also submitted a certificate from the Terna Mahavidyalaya, Osmanabad, stating that the said institution is not a Government College and was run by a private trust.

As such, no infirmity was found in regard to nomination of Mr. Jadhav, since Ministry of Youth Affairs Circular F. No.8-33/2020-SP-II/2, dated 30.12.2020 applied to employees under Govt./PSUs/Autonomous Bodies of State/Union Govt. and Mr. Jadhav was working in a private educational institution. In view of the facts mentioned above, I found no merit in the objections raised by Mr. Parab, in regard to the nomination of Mr. Jadhav, and the objections were consequently dismissed by way of a detailed order dated 22.06.2021.





2. The Competent Authority, KKFI appointed **Ms. Geetanjali Sharma**, Advocate Supreme Court of India & Sr. Govt. Counsel, Govt. of India / SAI as the Returning Officer (R.O.) vide KKFI Letter No. 3-5/KKFI/GC/2019-20, dt.12<sup>th</sup>Nov 2020 for procedural proceedings of the Elections. Accordingly, the R.O. consented for the same and prepared the Election Schedule for further circulation to all concerned as under:

4. Sh. Sudhanshu Mittal, President, Kho Kho Federation of India (KKFI) presided over the meeting online and deliberated the following:

- i) Ms. Geetanjali Sharma, (R.O.) addressed all the delegates present physically at G-7, 7<sup>th</sup> Floor, Dhawandeep Building, 6, Jantar Mantar Road, New Delhi-110001 and Online through Video Conferencing. The procedure was explained to all concerned. 



















The Meeting Notice for holding of General Council Meeting along with agenda points as per the date, time & location given above was circulated among all General Council Members of the Kho Kho Federation of India (KKFI) on 09<sup>th</sup> July 2020.

The President (KKFI) and all participants appreciated the efforts of Gen. Secretary, KKFI and extended wholehearted support for the future endeavours. The house adopted the Annual Report on working of the Federation unanimously.

## **Agenda Item No. 3: Consideration and passing of the Audited Statement of Accounts of the year and the budget for the next year.**

Sh. M.S. Tyagi, General Secretary, KKFI has apprized the house that the Audit Report & Statements of Accounts of the KKFI for the FY 2019-20 has audited by the CAG empanelled auditor M/s Gopal Mittal & Associates and the provisional Balance Sheet (BS) is being issued for the purpose of review and onward submission to the Income Tax Portal of Ministry of Finance for further authentication & adoption. It is also informed that in case of any observation received from the Income Tax on the provisional BS, the same shall be ratified with EC, accordingly. Otherwise, the same may be considered as Final & Approved.

The estimated budget for the Yr. 2020-21 was also circulated to all the General Council Member for consideration & approval.

**The provisional Balance Sheet for FY 2019-20 as well as Budget for the Yr. 2020-21 was duly approved and accepted unanimously by the house.**

## **Agenda Item No. 4: Appointment of Auditors and fixing their remuneration.**

Sh. M.S. Tyagi, General Secretary, KKFI has apprized the house that M/s Gopal Mittal & Associates is a CAG empanelled auditor and being associated with KKFI for Audit & the Statements of Accounts for the FY 2019-20 and accordingly, the same may be appointed for the next year i.e. 2020-21 as per the existing remuneration & norms.

**The house has duly accepted & approved unanimously to appoint M/s Gopal Mittal & Associates as Auditor for the year 2020-21 as per the existing remuneration.**

## **Agenda Item No. 5: Consideration of the Annual Kho Kho Calendar.**

The General Secretary, KKFI has apprized the house regarding various National / International Kho Kho Championships / Events to be conducted during the current calendar year. It was also discussed that the events shall be conducted only after the uplift of nCovid19 outbreak and resumption of physical training & sports activities.

**The General Council has appreciated the views of the General Secretary, KKFI and approved & accepted the Annual Kho Kho Calendar as per Annexure 2 unanimously.**

## **Agenda Item No. 6: Amendments to the Constitution, if any.**

The General Secretary, KKFI has proposed the following amendments in the constitution & bye-laws of the Kho Kho Federation of India:

- i) **Provision of "One State, One Unit" i.e. One State will have One State Association as per the IOA & NSDCI 2011.**

The EC Members from Kolhapur & Maharashtra requested to have a workable solution in view of the long standing of Kolhapur, Vidarbha & Madhya Bharat Kho Kho Associations. Keeping in view the above deliberations, the house unanimously decided that:

**A Committee be constituted by Sh. M. S. Tyagi, General Secretary, KKFI & Ms. Rani Tiwari, Vice President, KKFI to give recommendations for the merger of Kho Kho Associations functioning in one particular state i.e. Vidarbha & Kolhapur in Maharashtra and Madhya Bharat in Madhya Pradesh, so that the issue of One State, One Unit be resolved, keeping in view the provision in IOA & NSDCI 2011.**

## ii) Withdrawal of Voting Rights of Life Members as per IOA Constitution.

### a) Abolition of the provision of Life Membership in KKFI

The house deliberated the issue and it was unanimously decided to Abolish the provision of Life Membership & Founder Member to abide by the IOA Constitution as such the provisions in KKFI Constitution Clause 5.1 (viii), 5.1(xii), 5.1(xiii) (a), 6.1 (i), 6.2.1 (i), 6.2.1 (ii), 6.2.1 (ii) (b), 7 (para 1) & 14.1 (ii) may be amended/dropped with immediate effect.

### b) Abolition of the post of Chairman KKFI

The existing provision of the post of Chairman in the Constitution of KKFI at Clause 8.2 (para 3) was discussed and the house decided unanimously to drop the existing provision and abolish the post of Chairman with immediate effect.

## iii) Reduction of Quorum from 18 to 1/3<sup>rd</sup> of the effective strength of Representatives to convene the Executive / Special Executive Committee Meeting.

As per the provision in constitution clause 8.1, the EC constitutes of 31 members. However, due to various reasons such as death, resignations and other such reasons, the effective strength may vary from time to time.

After due deliberations the house unanimously decided to amend the constitution clause 13.4 (i) (iii) & (iv) with the provision to have 1/3<sup>rd</sup> of the effective strength of EC Members as on date to complete the quorum.

The house further decided unanimously to authorize President & General Secretary, KKFI to make any other amendment / incorporation in the constitution of KKFI required for the promotion & development of Kho Kho. The President desired to take further necessary action in this regard as per the amendments enclosed at Annexure 3.

## Agenda Item No. 7: Any other matter with the permission of the Chair.

### i) Resumption of Physical Training & Sports Activities for Kho Kho during present situation of COVID 19 pandemic.

The house unanimously approved to implement the Standard Operating Procedures for resumption of Physical Training & Sports Activities for Kho Kho.

### ii) Online Registration of Kho Kho Players & Officials on KKFI's Online Registration System i.e. [www.khokhofederation.in/ORS/Login](http://www.khokhofederation.in/ORS/Login)

The house impressed upon all the State/UT Associations to do the needful on priority basis and upload the same on KKFI Online Registration System.

### iii) To ratify the Elections of State Kho Kho Association already held since 2017 till date (as per Annexure 4)

The house unanimously ratified the elections of State/UTs Kho Kho Associations held since 2017 and further approved the affiliation as per nomenclature at Annexure 4. It was further resolved that issue pertaining to Tamilnadu & Odisha Kho Kho Association may be looked into by the Gen. Secretary & Ms. Rani Tiwari, Vice President KKFI to sort out the issue.

The house also decided unanimously to form a committee to ensure timely elections of other State/UT Kho Kho Associations well in time. Similarly, it was resolved that Uttar Pradesh State Kho Kho Association (UPSKKA) be looked after by the nominated Interim Committee towards promotion & development of Kho Kho in Uttar Pradesh.

- iv) Participation of affiliated State / UT in Senior, Junior, Sub-Junior Championships

**The General Secretary impressed upon the participation of all the affiliated States/UTs to participate in all the above National Competitions. The house unanimously endorsed the views of the General Secretary and approved the formation of the committee to suggest the ways & means to ensure the above participation and put forth measures to be taken for the needful.**

- v) Filling up of vacant posts in KKFI.

**The house unanimously decided to fill up all the vacant posts by Election and authorized President & General Secretary to appoint the Returning Officer (RO) for further actions. It was also decided that Sh. B. S. Tirthi will look after the work of Treasurer KKFI as Acting Treasurer with immediate effect until the election for the post shall be held.**

- vi) Reorganization of States/UTs

**The house unanimously decided to accord necessary approval i.r.o. the newly formed J&K (UT) and Ladakh separately in place of the State of J&K. Similar provision to be accorded for Dadra & Nagar Haveli and Daman & Diu.**

- vii) Dealing of Legal issues

**The house unanimously decided that the General Secretary, KKFI is authorized to initiate any Legal Suit and shall be competent to sign the "Vakalatnama" or other related legal documents including nomination of Advocate in all such cases.**

3. The chairperson thanked the participants for their considered views on various issues. The meeting came to an end with vote of thanks to the chair.

## Agenda Item No. 3: Registration of State and Districts Kho Kho Association.

- 3.1. It was pointed out that as per the Sports Code 2011 of Ministry of Youth Affairs & Sports (MYAS), the registration of the District and the State Associations is mandatory for compliance. It was emphasized that all State Kho Kho Associations must also form and register all the District Associations for required compliance, and also get the clubs registered for effective functioning and promotion of Kho Kho Nationwide. The State Kho Kho Associations (SKKA) must intimate the details as per **Annexure II**
- 3.2. The issue relating to the registration of Uttar Pradesh Kho Kho Association (UPKKA) was also deliberated and the house resolved the UPKKA will furnish the complete details latest by **30<sup>th</sup> Nov 2019**. The incentive shall also be released on its compliance. Since, President & Secretary, UPKKA were not present in the meeting, the issue was discussed by Sh. Santosh Singh, Jt. Secretary, UPKKA with his President over phone and on the request of the President, UPKKA, the Chairperson briefed him about the urgency of the matter and asked to comply within 15 days. It has also been desired by the President, KKFI to intimate the Name/Contact Details of State Olympic Association representative, who observed the latest Election proceedings of UPKKA.
- 3.3. It was decided to register the Players / Officials playing any indigenous game, on the Online Registration Portal i.e. [www.khokhofederation.in/register.aspx](http://www.khokhofederation.in/register.aspx) following the format annexed at **Annexure III**

**The President (KKFI) desired that all State Associations must comply with the requirement within a period of two (2) Months. The President also announced the GIA to SKKAs to complete registrations of their Districts/Units/Clubs etc. as well as emphasized online registration of players/officials in their region as per Annexure IV.**

**As per the decision of the house, UPKKA must comply the requirements w.r.t. the registration of State and District Associations. The same was conveyed over phone to the president, UPKKA by the President, KKFI for needful.**

## Agenda Item No. 4: Promotion & Development of Indigenous Games of India

- 4.1. The president KKFI intimated the house regarding the meeting with the Secretary (Sports), Govt. of India, in the presence of DG (SAI) regarding the promotion & development of Indigenous games of India in a big way. This was in conformity with the vision of Hon'ble Prime Minister to involve the masses in our indigenous games which include Gulli-Danda, Lattoo, Phitto, Kanche, Langdi Tang, Rope Skipping and many more. The is also aimed towards promotion of Fitness Campaign of "Fit India Movement" by adopting and preserving our traditional games.
- 4.2. Now that "Kho Kho" is being played all over India and the presence of State Kho Kho Associations (SKKA), we can contribute immensely towards the achievement of the objective. The house applauded the efforts and assured of devoted support.

- 5.2. All the delegates were impressed upon to submit the detailed plan for registration towards formation of Indigenous Games Association by 30<sup>th</sup> Nov 2019.
- 5.3. The Rules & Regulations / Kits in respect of conduct of IGs also to be formulated by 30<sup>th</sup> Nov 2019.
- 5.4. It was resolved to nominate the "Prabhari" for each association to oversee, guide and assist the State Associations to expedite the issue within the stipulated time-frame.

The elections of Kolhapur Kho Kho Association (KKKA) was held on 21<sup>st</sup> Sept. 2019 for the period of 2019-23. On the basis of Observer's report, the KKKA was De-Affiliated and an Interim Committee - KKKA was constituted vide KKFI's letter dt. 07.11.2019.

The matter was discussed with President, KKFI during the SAGM meeting and it has been observed that an enquiry may be conducted to investigate the matter and determine the factual position of the KKKA elections. The Final decision may be taken on the basis of on-ground report.

**The President, KKFI agreed to conduct an Internal Enquiry for the same and decided to Withdraw both, the De-Affiliation of KKKA and the subsequent Constitution of Interim Committee – KKKA, until further orders. It has been decided to ask KKKA to cancel the election of Sh. S. N. Nalawade, Gen. Secy., who has already attained the age of 70 Yrs.**

**As per the Constitution of KKFI/KKKA and Sports Code of MYAS, no person can seek election to the post of Gen. Secy. in the Federation after attaining the age of 70 Years. The election for the Gen. Secy. must be held within a period of 2 Months, latest by 31.01.2020 as per laid down procedures, till such time the senior most Jt. Secretary may perform the duties of Gen. Secy. KKKA as per the provision in the constitution.**

### 8.4. Elections of Kho Kho Association of Delhi

Delhi State Kho Kho Association was De-Affiliated on 4<sup>th</sup> June 2019 and an Interim Committee was duly constituted on approval of Executive Committee Meeting held on 2<sup>nd</sup> June 2019, to run and manage functionality & operations related towards promotion & development of Kho Kho in Delhi State with instructions to conduct elections of Delhi State within a period of Six Months.

The Interim Committee – Delhi (ICD) informed the house that they have already registered "Kho Kho Association of Delhi" and conducted a meeting on 3<sup>rd</sup> Nov 2019 and resolved the following:

- i) Out of 11 Districts in Delhi, 9 Districts Kho Kho Associations are already existing and the elections of Office Bearers for Kho Kho Associations of Delhi (KKAD) be held involving these 9 Districts as of now to promote & develop Kho Kho throughout Delhi, which may be considered & approved by KKFI.
- ii) To conduct the election process of KKAD by 30<sup>th</sup> Nov 2019 on the basis of above 9 District Kho Kho Associations.
- iii) KKFI may nominate the name of Observer for procedural proceedings of the said elections.



## 8.6. Delegation of Financial Powers


