Respected Ma'am,

I am directed to inform that Delhi State Kho Kho Association (hereinafter referred to as "DSKKA") headed by Smt. Kusum Bhardwaj as its President and Sh. Suresh Sharma as its Secretary General, has not furnished the required documents till now in-spite of prolonged correspondence & reminders from time to time, which is mandatorily required for the continuous recognition of Kho Kho Federation of India by the Ministry of Youth Affairs & Sports. The details are as under:

- i. Annual Report & Statement of Accounts.
- ii. Details of Elections
- iii. MYAS Compliance in prescribed format.
- 2. It is evident that despite various communications the DSKKA has failed to submit the above-mentioned documents required for the continuation of affiliation with KKFI. It has also been observed that DSKKA has deliberately repeated the negligence towards non-conducive of election nor furnishing the required information and also misleading the other State Associations & Affiliated units, which is working against the aims & objectives of KKFI and leading to irreparable damage to the image of Kho Kho Federation of India. This violation of ethical conduct emphasizes mismanagement and lack of coordination under DSKKA.
- 3. In view of aforesaid, the Executive Committee has unanimously decided to de-affiliate DSKKA with immediate effect and an interim committee shall look after the operations & functionality towards promotion & development of Kho Kho in Delhi State. The members are as follows:
  - i. Sh. Vinod Goyal, Former National Kho Kho Player and Chartered Accountant.
  - ii. Dr. Shubra Kathuria, National Kho Kho Player and Director, Physical Education, Bharti College
  - iii. Sh. Satbir Singh, Former National Kho Kho Player, Member (Selection & Referee Board) and Qualified Technical Official, KKFI
  - iv. Sh. Ajay Sahu, Former National Player, Physical Education Teacher & Eminent organizer of Kho Kho & Kabaddi sports
  - v. Dr. Kamlesh Sharma, Former National Kho Kho Player and Associate Professor, Delhi University.
