Sub: Renewal of recognition of Kho Kho Federation of India - reg.

Sir,

Kindly refer to your letter No. 36-01/2020-SP-III, dt. 05.04.2022 and even No. dt. 23.04.2022 and virtual meeting held on 30.5.2022 at 3.00 PM through video conferencing under chairmanship of Shri L.S. Singh, Joint Secretary (Sports) on the subject cited above.

In this connection, it is apprised that the amendments with respect to compliance of National Sports Development Code of India 2011 (NSDCI 2011) have been duly proposed to be incorporated into the Constitution of the Kho Kho Federation of India (KKFI) during the course of Special General Council Meeting of KKFI held via virtual mode on 22nd June 2022 at 11.00 AM onwards, which has been duly approved by the house unanimously. The details are as follows:

incumbent General Secretary or Treasurer after or before completion of the two terms each can contest for the post of President without any cooling off period. the post of Secretary, Treasurer or President.

In case of re-election of the office bearers, the instructions/guidelines issued by the Department of Sports, MYAS, Government of India, from time to time shall become automatically applicable in this regard.

7.1 ELIGIBILITY

The membership of the Federation shall be open to (i) Member Associations i.e. the State/ Union Territory Associations, (ii) Associate Members, and (iii) Athletes Committee Members.

i. Member Associations: shall mean a State/Union Territory Association.

State/ Union Territory Association shall mean an Association having jurisdiction applicable throughout the State/ Union Territory of India, formed to conduct, control and promote the sport of Kho Kho, having its rules and regulations, registered under State Societies Registration Act or Indian Society Registration Act 1860 or any other applicable statute, and having a legal presence certificate, where office bearers are elected on a periodical basis and may have affiliated member units.

ii. **Associate** Members: shall mean the institutions, departments, clubs, boards, etc.. accepted by the Federation for its' associate membership under the provisions of these Bye-laws of the Federation. An Associate Member shall not be a member of the General Council.

iii. Athletes Committee Members: Athletes Committee Members must be active athletes or retired athletes, having participated in the

7.1 ELIGIBILITY

The membership of the Federation shall be open to (i) Member Associations i.e. the State/ Union Territory Associations, (ii) Associate Members, and (iii) Athletes Committee Members.

i. Member Associations: shall mean a State/Union Territory Association.

State/ Union Territory Association shall mean an Association having jurisdiction throughout the applicable State/ Union Territory of India, formed to conduct, control and promote the sport of Kho Kho, having its regulations. rules and registered under State Societies Registration Act or Indian Society Registration Act 1860 or any other applicable statute, and legal presence having a certificate, where office bearers are elected on a periodical basis and may have affiliated member The duly affiliated State/UT Members shall have a right to vote, through 2 authorised representatives, with one vote each, in the meetings of the General Council and in the elections of office bearers and the members of Executive Committee of KKFI.

ii. Associate Members: shall mean the institutions, departments, clubs, boards, etc., accepted by the Federation for it's associate membership. The Associate Members of the Federation shall not have any voting rights.
