**Sub: Conduct of 31<sup>st</sup> Sub-Junior National Kho Kho Championship 2021-22 (Boys & Girls) –Conduct of Selections for Players of Uttar Pradesh thereof.**

Dear Sir,

We are in receipt of your letter dated 11<sup>th</sup> of November 2021, which has been addressed to Director Sports, Uttar Pradesh and copy marked to KKFI. In the said letter, you have stated that the selection for the purpose of participation of players in the 31<sup>st</sup> Sub Junior National KhoKho Championship, 2021, will be conducted by you on 15<sup>th</sup> November 2021, at 10 AM onwards, in Ayodhya.

You are aware that UPKKA was de-affiliated by KKFI w.e.f. 30.01.2020, and therefore, is not an association affiliated to KKFI as on today. However, you have incorrectly stated on your letterhead that your Association is affiliated to KKFI, which is incorrect. You are advised to remove the said incorrect fact immediately from your letterhead, which is misleading the sports-persons and other stakeholders. After 30.01.2020, the KKFI has not received any application till date, for re-affiliation from UPKKA in accordance with the procedure prescribed in Rule 7.2.5 of the KKFI Constitution. Therefore, please take note that the selections conducted by you shall not be recognised by the KKFI.

You may present an application for re-affiliation to KKFI, along with complete details including complete details of office bearers and members of executive committee, affiliated units, and relevant documentation, adherence of the KKFI Constitution and rules applicable with respect to the Govt. Employees in Sports Associations, which application shall be considered by KKFI, in accordance with the applicable rules.

In view of the foregoing, to protect the interest of the sportspersons in Uttar Pradesh, to conduct the selections for the upcoming 31<sup>st</sup> Sub Junior National Kho Kho Championship, 2021, a panel comprising of following eminent sports-persons and coaches have been formed by the KKFI:

- i) Smt. Sudha Rani Tiwari, NIS qualified Kho Kho Coach
- ii) Sh. Vinay Kumar Jaiswal, NIS qualified Kho Kho Coach
- iii) Sh. Radheyshyam, NIS qualified Kho Kho Coach


- iv) Dr. Preety, Outstanding Kho Kho Player & Lecturer
