

## **SCHEDULE OF ELECTIONS**


<b><u>NOTICE OF AGM</u></b>  <b><u>11.06.2025</u></b>	<b>5 DAYS PRIOR TO DAY 1. 21 CLEAR DAYS PRIOR TO VOTING. APPOINTMENT OF RO MAY BE MADE BY THE PRESIDENT A DAY AFTER THE NOTICE OF AGM IS ISSUED.</b>
<b>BY OR BEFORE DAY 1</b>  <b>16.06.2025</b>	With reference to the Letter No. 3-5/KKFI/Cord/2025-26, Dated: 12.05.2025 - Each duly recognized and affiliated State/UT member association has sent already name of the two representatives to the KKFI (as per Last date) for the AGM.
<b>DAY 2</b>  <b>17.06.2025</b>	The President/General Secretary of KKFI shall prepare the list of the Authorized Representatives the whose names are nominated by the recognized and affiliated State/UT Member Associations in Form 1, and circulate a copy of the list so prepared amongst all Affiliated Members by display, on the website of KKFI. A duly authenticated copy of his list shall also be furnished to the RO as soon as practicable after his appointment by the President.
<b>DAY 3 TO DAY 5</b>  <b>18.06.2025 TO 20.06.2025</b>	The nomination paper(s) of a candidate for election as Office Bearer or member of the Executive Committee shall be submitted to the RO by the candidate himself/herself from Day 3 to Day 5, between 11:00 am and 1:00 pm.
<b>DAY 7</b>  <b>22.06.2025</b>	After 1:00 pm on Day 7, the RO shall prepare a list of all nominations received by him in Form 3, and publish the same in a conspicuous place in his office.
<b>DAY 8</b>  <b>23.06.2025</b>	On Day 8, at 11:00 am, the RO shall scrutinize each nomination paper received by him and determine its validity or otherwise.
<b>DAY 8 TO DAY 10</b>  <b>23.06.2025 TO 25.06.2025</b>	Each Candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, from Day 8 until 1:00 pm of Day 10.
<b>DAY 11</b>  <b>26.06.2025</b>	As soon as after 11:00 am on Day 11, the RO shall prepare the final list of Contesting Candidates in alphabetical order of their names, in Form 6, and display a copy of the same in a conspicuous place in his office and on the website of KKFI.
<b>DAY 16</b>  <b>02.07.2025</b>	Where the number of Contesting Candidates for any post or category of posts, in Form 6, is equal to the number of posts to be filled, all such candidates shall be deemed to be duly elected unopposed to the said posts.  The Poll for the remaining posts shall take place during the AGM on Day 16 during the Agenda Item 'Elections' at the venue of the elections.

### **Relevant Rules of KKFI Constitution to be kept in mind**

**Rule 10.2(iv)- Nominations to be received at the office of federation 14 clear (working) days before the election date.**

**Rule 10.2(vi)-Appointment of RO by GS in consultation with President. To be ratified by EC subsequently.**

**Rule 10.2(vi)- Nominations can be withdrawn 5 days prior to the date of election**
