All the eligible players may participate in the Selection Trials following the selection criteria for 35<sup>th</sup> Sub Junior National Kho Kho Championship as per KKFI Index formula (i.e. All participating Players (Boys & Girls) must be **14 Years or below 14 years** of Age as on 04<sup>th</sup> February, 2026 {Age + Height in CMS + Weight in KGs = Its score should not exceed the **215 points** in both categories}).

Further, the entire selection process shall be video graphed. The details in this regard shall remain available on the KKFI website [www.khokhofederation.in](http://www.khokhofederation.in).

Please note that only the sportspersons selected in pursuance of the selection trials mentioned above will be considered for participation in the 35<sup>th</sup> Sub Junior National Kho Kho Championship (Boys & Girls) 2025-26 by the KKFI, after their registration on the KKFI Online Registration Portal i.e. <https://khokhofederation.in/ORS/register>.
